CONTEXT FOR THE TASK:

This task will draw together the above outcomes to provide students the opportunity to demonstrate their knowledge of concepts and content covered in the first topic of Crime. It will also give them the opportunity to synthesise and respond to questions using cases. This task will allow students to gain feedback on areas of strength and areas in which to improve for their HSC. The structure and questioning style of the extended response component is modelled off the HSC Legal Studies examination question on crime.

TASK DESCRIPTION:

In this assessment task, students will be assessed on their ability to demonstrate an understanding of the concepts covered in the core topic of Crime. It will provide an opportunity for students to develop an understanding of criminal law through the investigation of a contemporary criminal case of their choice. In addition, students will answer an extended response in which they are required to evaluate the extent to which the law balances the rights of victims, offenders and society.

An accurate bibliography must also be included. All material should be referenced according to the school policy.

TASK OUTLINE

There are 2 parts to this assessment task:

PART 1: RESEARCH TASK

Research and write a report on an indictable criminal offence that was prosecuted in the NSW criminal justice system within the last 5 years where the defendant was found guilty. You should write your report using headings and subheadings. Your report should be approximately 1,200 words and must set out the following information:

- identify the correct legal citation (title) of the case
- outline the facts of the case and elements of the offence
- identify the category/categories of crime relevant to the case and describe the factor/s that might have led to the criminal behaviour
- identify the Act/law including the section(s) of the Act/law relevant to the case
- outline the reporting and investigation of the crime
- explain the role of the court
- outline the role of legal representation
- identify the plea
- discuss the factors that affected the sentencing decision
- explain the penalty (sentence) given
- assess to what extent does the law balance the rights of victims, offenders and society in your case?
- provide a referenced bibliography

PART 2: CRIME ESSAY (Extended Response)

During class time on Monday 11th December 2023, students will complete an in-class essay in response to the following question:

"Evaluate the extent to which the law balances the rights of victims, offenders and society?"

TIPS

- Students should begin their preparation by reading over their class notes and relevant sections of the textbook.
- Students should also investigate relevant websites e.g. those referred to in the textbook, AUSTLII and the State Library Research Guides for Legal Studies.
- Students need to understand that Evaluate means to make a judgement based on criteria(s) or determine the value of something.
- Essay format must be used i.e. there needs to be an introduction, main body and conclusion. Paragraphs should be used (no headings or bullet points).
- The essay must be in the third person e.g. do not say 'I think...', 'My opinion is...', instead write things like 'The evidence suggests...' or 'It appears clear that...'
- Students need to use a range of legal terminology, concepts and examples where appropriate.

DETAILS FOR SUBMISSION

This assessment will be both a hand-in task and an in-class essay to be completed in your timetabled lesson on Monday 11th December 2023. Students are to submit a hard copy of their case and report at the start of the lesson before they commence the in-class essay.

Students must bring the required equipment for the examination, which is a black or blue pen. All writing paper will be provided. Students are NOT permitted to bring notes into the exam.

To avoid a zero mark being awarded, any absence must be supported by valid misadventure/illness documentation outlined in the Year 12 Assessment Booklet.
