### Part A:

- Outline the development of protection of the human rights issue (legal methods)
- Relevant statistics regarding your chosen human rights issue
- Assess legal and non-legal responses to the issue
- Discuss the impact of the human rights issue on victims and society
- Include a bibliography using an approved referencing format.
