TASK DESCRIPTION:

This research task is structured in TWO parts. Part A is worth 10 marks, Part B is worth 15 marks.

PART A: Using at least three distinct sources: Research the following aspects of German Society and Culture, examining how each was transformed under Nazism.

Society – Women , Youth, Religion

Culture – Literature, Music, Art, Cinema

Submit a written summary of your findings covering each aspect, as well as a correctly formatted list of sources used. Expected length: 4 typed A4 pages.

PART B: Use your research from part A to write a 1500 word extended response to answer the following question.

Evaluate the extent to which the National Socialist revolution 1933-1939 impacted German social and cultural life.

ASSESSMENT CRITERIA – STUDENT CHECKLIST:

You will be assessed on your ability to:

- Undertake effective research into the various aspects of German Society and Culture
- Determine how each aspect was transformed under Nazism
- Make an informed evaluation as to the extent of this transformation
- Write a well-structured, well -argued extended response that uses specific historic detail and source evidence.

Research Summary

<ul style="list-style-type: none"> - A comprehensive, well-structured summary providing detailed and relevant information on the transformation of the nominated aspects of German society and culture. - Treats all aspects equally, not favouring some over others. - Includes a correctly formatted list of at least 3 sources - Clearly meets expected length 	9-10
<ul style="list-style-type: none"> - A well-structured summary providing substantial relevant information on the transformation of the nominated aspects of German society and culture. - Covers all nominated aspects but may be uneven in treatment. - Includes a formatted list of at least 3 sources - Satisfies expected length 	7-8
<ul style="list-style-type: none"> - A clear summary providing relevant information on the transformation of the nominated aspects of German society and culture. - Likely to be uneven in treatment of various aspects. - Includes a list of 3 distinct sources but may be incorrectly formatted. - Satisfies expected length 	5-6

<ul style="list-style-type: none"> - Presents a structured, but largely narrative or descriptive response that demonstrates an understanding of the impact of the National Socialist revolution on German Society and Culture. - Provides adequate and mostly accurate historical information that incorporates some historical terms. - Historical source evidence may be used unevenly or intermittently throughout the response. - Satisfies length expectation. 	7-9
<ul style="list-style-type: none"> - Presents a general narrative or descriptive response regarding the transformation of German Social and Cultural life under the Nazis. - Presents basic relevant historical information which may incorporate some historical terms. - Use of historical source evidence is likely to be minimal. - Unlikely to meet length requirement. 	3-4
<ul style="list-style-type: none"> - Brief generalised response about life under Nazi rule, containing limited historical information. - Unlikely to make use of historical source evidence. - Does not meet length requirements. 	1-2

- The title of the Book or Journal is in italics.
- Where an article has been used from a journal, the pages the article is on are shown.
- For websites, the URL is listed AFTER the title, website and date of access has been shown.
